Test Entry / Limitations

Test limited to 3 TD and 2 TDX entries (Flat-Coated Retrievers only). If the entry limit is not reached in one test & the entry limit is exceeded in the other test, the number of tracks may be exchanged through plotting day, up to a maximum of 4 TDs or 3 TDXs. The following substitution rule will be used: 2 TDs = 1 TDX.

Closing date: Wednesday, March 19, 2008, 6:00 pm after which time entries cannot be accepted.

All entries will be accepted until the official closing date & time, even if the advertised limit has been reached.

Entry Fee: TD - \$50.00; TDX - \$90.00. Fee includes \$2.00 AKC Recording & Service Fees. Make checks payable in \$US to: 2008 Specialty.

Certification: Each TD entry must be accompanied by an original certification issued by an AKC approved tracking judge. Dogs that possess a title of TD are exempt from this requirement.

Entry Drawing

A drawing to select entrants and alternates will be held on Friday, March 21, 2008 at 6:00 PM at Sodbusters Restaurant near the intersection of US 97 and WA State Highway 142 in Goldendale, Washington. Entrants are invited to attend.

The drawing will be random except that preference will be given as follows:

(1) Flat-Coated Retrievers without a TD or TDX title, (2) Flat-Coated Retrievers with a TD or TDX title.

After 3 TD and 2 TDX entries have been drawn, all remaining entries will be assigned a numerical ranking on an alternate list corresponding to the order in which they were drawn.

Alternates

Alternates will be asked to be at the test site in case of absent dogs. Alternates not used will receive full refund of entry fees. FCRSA, Inc. will also refund fees to any confirmed entry who withdraws from the test, by written or phone notification to the Test Secretary, prior to the track draw on Saturday, April 12, 2008, provided that an alternate entry participates in the test as a result of the withdrawal.

Track Draw

All TD dogs must be at the Visitor Center parking area by 8:00 AM, Saturday, April 12, 2008. All TDX dogs must be at the Visitor Center parking area by 9:30 AM, Saturday April 12, 2008. At those designated times, a drawing will be held for tracks for each dog entered. The first track for each test will be run after the track aging requirement has been met. In the event of any absentees among confirmed entries, the next alternate, in catalog order, that is present, will be allowed to fill the vacancy.

BITCHES IN SEASON ARE NOT ALLOWED TO PARTICIPATE.

Parking: Sufficient parking is available at the Champoeg State Park. Please do not block roadways or exit aisles with your car or setup.
